As a Participant in any World Championship, World Tour, World Tour Grand Finals, Junior Circuit, Para Table Tennis Events or any other ITTF events (each as "Event", collectively as "Events"), I hereby irrevocably and unconditionally acknowledge and agree, that throughout my entire registration with International Table Tennis Federation (the "ITTF"), my participation in the Events is conditional upon my acceptance of and my compliance with all the provisions of these Conditions of Participation and related rules herein in force at the time of the respective Event, as regularly amended and approved by the ITTF and the organizing committee for the respective Event (the "LOC").

1. Capture and Use of Images: Participants may be filmed and photographed during the Events.

In consideration of the acceptance of my participation therein, I agree to be filmed, televised, photographed, identified and/or otherwise recorded during the ITTF Events. I also agree that my captured or recorded image produced from the Events and the related intellectual property rights shall be owned by the ITTF. I consent to the use of my captured and recorded image, together with my name, likeness, voice, performance and biographical information, in any content, format and through any media or technology whether now existing or created in the future, by the ITTF and third parties duly authorised by the ITTF during and after the respective Event, in a commercial or non-commercial manner, exclusively for the celebration and promotion of the Events, the ITTF, and the Table Tennis Sport.

2. Processing of personal information: ITTF Events and authorities of the country where any Event is hosted require access to certain information.

I agree to personal information about me (the "Personal Data") being collected by the ITTF and the LOC and to such data being stored and used by the ITTF and the LOC in any place required for its operation, for the purposes of facilitating my participation in, and/or organising, the Events. This consent includes the right for the ITTF and the LOC to collect and process my Personal Data, including where necessary to share such data with law enforcement authorities and other third parties, in all manners necessary for the following purposes:

- a. security risk assessments carried out by the respective national authorities;
- b. investigation and/or prosecution of breaches of any of the provisions referred to in paragraph 3 below (which may require, for example, the collection and analysis of blood and urine samples for doping related cases or of other relevant information in relation to the prevention of the manipulation of competitions);
- c. statistics, historical studies and other ITTF-approved research projects conducted during and after the respective Event;
- d. any other data processing operation to which I provide my express consent to the ITTF and/or LOC;
- e. for Participants under the age of 18-years-old at the date of signing this form: in order to enable the validation and confirmation of my participation in the Events, I hereby acknowledge that I must comply with the specific laws and regulations applicable to the participation of Minors in the Events in the country where the respective Event is hosted.

3. Compliance with the ITTF Handbook and related rules: participation in the Events is subject to the compliance with the fundamental rules governing the ITTF and the Table Tennis Sport, to ensure the Events' integrity.

I confirm that I have full knowledge of the provisions applicable to my participation in the Events and that I agree to comply with all the rules in force and responsibilities applicable to my participation in any respective Event, in particular those arising from the following texts:

- a. the ITTF Handbook and, in particular, the ITTF Constitution, the Regulations for International Competitions, and the ITTF Anti-Harassment Policy;
- b. the World Anti-Doping Code, as well as the ITTF Anti-Doping Rules and any related regulations in force at the time of the respective Event, as they may be amended from time to time, in particular, the requirement to be available for Sample collection at all times;
- c. the ITTF Regulations against Illegal Betting and Corruption and thus I will not participate in, support (including by disclosing inside information) or promote betting related to the Events;
- d. the ITTF Code of Ethics, including the Code on the Prevention of Manipulation of Competitions;
- e. the ITTF World Tour Directives, Sport Specific Information regarding Players' obligations and any other related documents and directives.

I confirm that the above referred texts and all the rules in force at the time of the respective Event, and responsibilities applicable to my participation in the Events, are brought to my attention by my National Table Tennis Association and by the ITTF, among others through the ITTF's official webpage.

4. Acknowledgment and acceptance of risks while participating at the Events: insurance is required to participate in the Events.

I ensure that my participation in the Events is sufficiently protected by medical, travel and other appropriate insurance; that I will take all reasonable measures to protect myself from the risks of participation; that I am responsible for all property I bring into the Events venue and that the ITTF and the respective LOC shall have no responsibility for any loss or damage to this property. To the fullest extent admissible under applicable laws, I irrevocably release the ITTF and the respective LOC (and their members, directors, officers, employees, volunteers, contractors or agents) from any liability for any loss, injury or damage that I may suffer in relation to my participation in the ITTF Events.

5. Arbitration: the Court of Arbitration for Sport is exclusively competent to finally settle all disputes arising in connection with the participation in the Events which have not been resolved by the ITTF.

I agree that any dispute or claim arising in connection with my participation at the Events, not resolved after exhaustion of the remedies established by the ITTF and the LOC, shall be submitted exclusively to the Court of Arbitration for Sport (the "CAS") for final and binding arbitration in accordance with the Code of Sports-related Arbitration. The seat of arbitration shall be in Lausanne, Switzerland and the language of the procedure English. The decisions of the CAS shall be final and binding. I hereby waive my right to institute any claim, arbitration or litigation, or seek any other form of relief, in any other court or tribunal.

6. National Table Tennis Association's confirmation: the NA hereby guarantees that all delegation members, in particular the Players, are sufficiently protected by appropriate insurance programs under article 5 above, as precondition to participation in the Events; that the relevant rules and their subsequent amendments in force at any respective Event, including all those referred to above, shall be respected and brought to the attention of the Participant; and that the NA is competent to sign these Conditions of Participation.

I confirm that I have read and irrevocably agreed to all the provisions of these Conditions of Participation and that my signature below is authentic and is the signature of the Participant named above, which shall be binding throughout my entire registration with the ITTF.

in connection with the Events. Such Team Coach shall have the power to appoint a substitute or to delegate all or part of such powers to other persons of his/her choice. I consent to any medical treatment being administered to the Participant in the case of any injury or illness whilst the Participant is participating in the respective Event.

4. Release and Waiver: In consideration of the acceptance by the ITTF and the LOC to the Participant taking part in the ITTF Events, I irrevocably release the ITTF and the LOC (and their respective members, directors, officers, employees, volunteers, contractors or agents) from any liability (to the extent permitted by law) for any kind of loss, injury or damage that the Participant may suffer or be exposed to in connection with the Participant's participation in the Events.

5. Arbitration: I agree that any dispute, controversy or claim arising out of or in connection with this Acknowledgment of Consent for Minors which cannot be settled amicably shall be submitted exclusively to the Court of Arbitration for Sport (the "CAS") in Lausanne, Switzerland, for final and binding arbitration in accordance with the Code of Sports-related Arbitration. The seat of arbitration shall be at Lausanne, Switzerland and the language of the procedure English. The decisions of the CAS shall be final and binding. I hereby waive my right to institute any claim, arbitration or litigation, or seek any other form of relief, in any other court or tribunal.
